## Representative Matters

In May 2012, Tom argued the appeal of General Mladen Marka before the Appeals Chamber of the International Criminal Tribunal for the Former Yugoslavia (ICTY) in The Hague, Netherlands. Gen. Marka was the Assistant Minister of Interior and Commander of Special Police (equivalent to Special Forces) in Croatia in 1995 who was sentenced to 18 years of imprisonment by the ICTY's Trial Chamber for allegedly committing crimes against humanity and violations of the laws or customs of war from August to September 1995. Tom began his representation of Gen. Marka in 2007. The trial began in March 2008 and was completed in August 2010. Gen. Marka was acquitted on all charges when the Appeals verdict was rendered in November 2012.
