**Webinar 3: 2019 in Review for LHCSAs and FIs, and What to Expect in 2020**

**December 16, 2019**

2019 was a busy year for home health care providers in New York State. The budget season resulted in angst and uncertainty for fiscal intermediaries and entities wishing to become a fiscal intermediary. Plans closed and other plans assumed the patients, under unfair conditions in many cases. The 24-hour live-in issue was finally decided by the New York State Court of Appeals. Wage Parity audits and government scrutiny continued. DOH tried – and continues to try – to reduce reimbursement for fiscal intermediaries. The federal overtime regulations were changed, with effective dates on January 1. The sexual harassment laws and regulations were fully phased in, and amended. This webinar will review all the changes that you might have missed in 2019 and discuss some legislative priorities and agenda items that providers may wish to consider as the 2020-2021 New York State budget season kicks off in January 2020!
