

FIFTY-FOUR HODGSON RUSS ATTORNEYS NAMED TO BEST LAWYERS 2013

Fifty-four Hodgson Russ attorneys have been selected by their peers for inclusion in *Best Lawyers in America 2013*[®] (Copyright 2012 by Woodward/White, Inc., of Aiken, S.C.).
