Factors considered in evaluating candidates include, but are not limited to: verdicts and settlements, representative clients, experience, honors and awards, special licenses and certifications, bar and or other professional activity, *pro bono* and community service, scholarly lectures and writings, and other outstanding achievements.

In the area of personal injury defense: medical malpractice, Emily M. Ballenberger was acknowledged for her work. A member of the firm's Mount Clemens office and Medical Liability Practice Group, Ballenberger focuses her practice primarily on the defense of physicians, physician's assistants, hospitals, and other healthcare professionals involved in medical malpractice or section 1983 litigation.
